

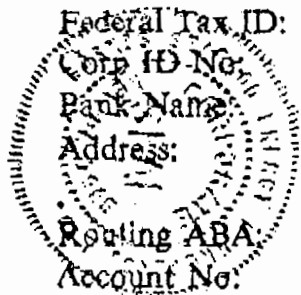


Dear John,
